Memorandum of Understanding: EMERGENCY HOUSING AGREEMENT

Yellowstone County Youth Services Center – Crisis Shelter Care (YSC) and Yellowstone Boys and Girls Ranch (YBGR) agree to the following arrangements:

1. In case of emergency at YSC, where immediate or planned evacuation is necessary, YBGR agrees to provide temporary housing for youth and staff of YSC.
2. YSC will contact YBGR as soon as possible during an emergency. YSC will contact one of the following YBGR personnel in the following order:

3. Upon arrival at YBGR the YBGR representative will meet the group leader from YSC at the Administration Building. YSC will notify their food vendor of the disruption as soon as possible and arrange for meals to be delivered to YBGR. YSC and YBGR will develop a plan for the immediate shelter and contingency plan for extended shelter.

4. YSC will be responsible for providing all necessary supervision of YSC youth during their temporary stay at YBGR.

5. YSC will contact YBGR to determine details of financial costs incurred during the emergency period.

6. This agreement is effective 5/15/2025 and remains in effect until notification from either party.
