

ADDENDUM TO PROFESSIONAL SERVICES AGREEMENT
72-HOUR HOLD UNIT

This Addendum ("Addendum") supplements the Professional Services Agreement dated on or about June 30, 2025 (the "Agreement") between Ivy Medical, PLLC dba Ivy Corrections Medicine ("Ivy") and Yellowstone County ("Client").

BACKGROUND

1. In addition to the Services provided in the Agreement, Client seeks to have Ivy provide Services in its 72-hour Hold Unit ("Unit"), including screening of Detainees who are detained in the Unit.
2. To accommodate the additional Services rendered in the Unit, the parties agree to the additional compensation set forth in this Addendum.

AGREEMENT

1. IVY RESPONSIBILITIES FOR UNIT SERVICES. Ivy shall provide the following services in the Unit through its Personnel ("Unit Services"). Ivy shall render the Unit Services to Detainees in the Unit in lieu of the Services described in Attachment 2 of the Agreement.

(a) Conduct intake screenings for all new bookings using a shortened version of the screening process currently in place at the Facility.

(b) Perform nursing rounds twice daily to identify acute medical needs, set up medications, and prepare for medication passes. All medications will be approved by an Ivy physician or APP before administration.

(c) Pass medications twice daily.

(d) Provide suicide clearances as required.

2. CLIENT RESPONSIBILITIES FOR UNIT DETAINEES. Between rounds by Ivy Personnel, detention officers will remain responsible for monitoring patients and promptly notifying Ivy Personnel if concerns about detainees arise.

3. COMPENSATION FOR UNIT SERVICES. As compensation for the additional Services performed in the Unit, Client shall compensate Ivy as follows:

3.1 General. The compensation set forth in Attachment 2 to the Agreement shall also apply to Services performed in the Unit, including but not limited to the ADP Fee contained in Section 2 of Attachment 2. Detainees in the Unit shall be included in the ADP for purposes of calculating the ADP Fee as set forth in Attachment 2.

3.2 Booking Fee. In addition to the other compensation payable under the Agreement and this Addendum, Client shall pay to Ivy the amount of Forty-Nine Dollars (\$49) per booking in excess of seven hundred (700) bookings per calendar month ("Booking Fee"). The total number of bookings in the Unit, the Facility and any other location at which Ivy renders Services or Unit Services shall be included when calculating the number of bookings for the Booking Fee.

4. **ADDENDUM EFFECTIVE DATE.** This Addendum shall be effective 10-20-25, 2025 ("Addendum Effective Date"), and shall apply to all Services rendered in the Unit on or after the Addendum Effective Date.

5. **REASSESSMENT.** The parties agree to reassess this Addendum (i) 90 days after the Addendum Effective Date, and (ii) 180 days after the Addendum Effective Date to ensure that its terms are appropriate. Upon request by either party, the parties shall negotiate in good faith to amend the Addendum. If the parties cannot agree on an amendment, either party may terminate this Addendum on thirty (30) days' prior written notice.

6. **OTHER TERMS.** The remaining terms in the Agreement shall apply to Services rendered in the Unit to the extent not inconsistent with this Addendum.
