<u>Change Order No.2 – Justification (Revised):</u>

Item No.1: PR-10 - Walkway to Train:

The Museum has wanted to get a handicapped walkway from the train to the public sidewalk for some time and saw this as an opportunity to combine this work with the existing construction. The price was still than the Museum felt was appropriate to invest in this project.

Item No.2: PR-9 - Duplex Outlet:

The relocation of the entry into the McCormick cabin from the inside the west cabin created the need for an additional interior duplex outlet where the original access was planned.

Item No.3: PR-11 - Replace Electrical Distribution Panel "A":

Electrical panel "A" was original to the building that needed to be brought up to current buildings codes, and was mounted on the McCormick Cabin stair stringers that are being removed and filled in with new flooring. The old panel was a safety concern that needed to be mitigated.

Item No.6: PR-13— Shim & Level Ceiling in West Cabin:

The bottom cord of the existing roof joists in the west cabin is not level requiring extensive shimming to get the ceiling level enough to sheetrock.

Item No.7: PR-14- Reinforce Existing Stepped Footing South Wall West Cabin:

The existing south wall footings of the west cabin did not extend down to the new floor level requiring additional reinforcement (concrete).



Sheet A-1.01 Keynote 4 states to remove existing stairs, framing, and handrails complete.

Sheet A-1.03 Keynote 2 States to provide & install new structural subfloor to enclose removal stainwell - see structural

The Structural Page Sheet S-1.02 Main Level Framing Plan Shows us providing new plywood deck, new 2x10 or smaller joists to match existing and potentially 3 joists 'sistered' to existing joists after the supporting wall is removed.

Sheet S-1.02 also states that support details to be provided after stair demo and existing structure is exposed.

On October 1st, Bill Oakey visited the site and directed us to add new walls to support the structure that are not shown on the bid set of plans. (Please see attached email chain) This includes 25 LF of New Walls at 8' 1" Tall along with 80 LF of new 2 x 6 joists needed to match the existing structure.

Along with this cost, we also encountered issues with meeting ADA Requirements at the opening between Original Cabin 104 and Reception 100. The plans show this opening at the North Side of the Building but per owner request, we moved it to the South with zero cost. However we had no way of knowing that the elevation at the South West Corner of Original Cabin 104 was going to leave us with a 2" offset at finish floor where it meets the finish floor of Reception 100. Per ADA Requirements, this 2" offset is unacceptable. TW Ridley and Spectrum met on site on 10/9 and agreed the best course of action is to plane out the new 2x6 joists to create a gradual slope at the start of the new structural subfloor and then provide a pony wall where the transition is to meet ADA Requirements. This Pony Wall is 6.5 ft long x 4 ft Tall and is to be finished with Stained Plywood.

This cost also includes added General Conditions / Supervision Time due to needing to push back our flooring date to allow time for the framing crew.

This cost excludes the additional work to patch the roof membrane on the deck (to be submitted as a separate cost)

This offset created a delay because we had to wait until the the opening was completed 100% to verify that measurement to the design team so that the Red-built plans could be revised. This has resulted in a delay in procurement for the Red-builts which is a critical path item that will add time to the overall duration of the project. A General Conditions Cost will be incurred because of this.

We still need the time extension but we are

- 2. In order to hang sheet rock on the ceiling, all of the existing trusses needed to be planed / shimmed out to create an even surface for the sheet rock to mount to. This has resulted in increased labor on the job. No time will be added for General Conditions due to us being ahead of schedule on the remodel portion of the job.
- 3. Existing Stepped Footings on existing building were requested to be formed and encased in concrete. This has resulted in increased labor and material for the concrete scope. No added time for General Conditions will be included due to us being able to perform this work alongside the originally scheduled concrete walls.
