Meeting called to order at 1208 hours.

Members received the July meeting minutes via email. Sam made a motion to approve the meeting minutes without corrections. Karen seconded. Motion approved.

Members received the latest budget reports via email. No questions were brought forward.

Travis provided a social media update. He provided information on a message from the Department of Revenue and safer drinking strategies. Some emojis used send a potentially confusing message that buzzed driving is acceptable; DUITF might send a letter to reconsider.

The Ales for Trails event takes place on Friday, August 29. Kacy will provide the water; Monty along with Kevin and Darla will help with setup; Shaun Pisk volunteered to work the 6:00-8:00 as did Guest Beth Allen 6-8. Sam Morris will also work 6:00-8:00. Haley will work 6:00 until close and Andy will man the first aid station at the next table.

Travis provided information on the sunshades promotional products - \$1,000 \$4.50/unit; \$2,500 \$2/unit - sunshades only-he encourages us to include a message. He could possibly get a sample of the product. Karen will commit additional \$1,500 to get into lower price point but will need Bridgemont co-branded.

During the Symposium planning meeting the group agreed upon sponsorship levels and the number of sponsorships for each category; we will explore bringing the ND car to the event, and the group agreed to keep the exhibitor tables at \$250.
