Attendance

Board members: Pres. Brandy Dangerfield, Vice Pres. Woody Woods, Sec. Zachary Hassler, Pam Ask, Tim Sather, Travis Smith

Board members not in attendance: Tobin Novasio

Dangerfield called the meeting to order at 7 p.m. and began by seeking public comment. There were **no public comments** provided.

Sather motioned to approve March minutes. Smith seconded. Motion carried with unanimous voice vote.

Woods updated the group on the solution for the drainage issue near the baseball field at the end of the ongoing Old Hardin Rd sidewalk construction project. **Woods motioned to approve a valley gutter at the location for a cost of \$11,107.50, which is expected to be split between Yellowstone County and LPSD. Ask seconded. Motion carried with unanimous voice vote.** This cost was a significant savings over the most recent estimates of \$22,000-\$35,000 and the earlier culvert solution that had an estimated cost of up to \$40,000.

Dangerfield initiated discussion on the Highway 87E Massick Property sidewalk gap. In weeks leading up to this meeting, Mark Dearing with the school sent an email to Erin Claunch saying the school had selected a contractor. Claunch said he had contacted the school's contractor, and the contractor informed him the price the school negotiated was for concrete only. Claunch said additional work will be required to prep the site for concrete, such as placing gravel and performing compaction. Ask suggested Claunch contact Tobin Novasio to coordinate and confirm the school's plans for site prep. Claunch said there could be issues with maintenance staff performing site prep since the work will be in MDT's right of way. Claunch said he'd try to contact Novasio to work through the issue and push towards construction as soon as feasible.

Dangerfield informed the group Novasio intends to stay on the board while he lives Lockwood and commutes to his new job as superintendent in Hardin.

Dangerfield said she'd been reimbursed for PILT funds related to the May 3rd Bike + Helmet giveaway. 120 helmets and reflective slap bands were delivered to the school on 5/19/23. Dangerfield did not receive additional bikes from former board member Hecker, but she said she'd try contacting Hecker.

The LPSD annual budget meeting remains scheduled for June 27, 2023. Woods said he'd recently met with Jen with Yellowstone County to review LPSD's current balances and next year's projected budget.

Dangerfield adjourned the meeting at 7:30 p.m.
