PROPERTY TAX ASSISTANCE (PTAP)

The Property Tax Assistance Program (PTAP) helps citizens on a fixed or limited income by reducing the property tax rate on their home. The PTAP benefit only applies to the first \$350,000 of your primary residence's market value. Your income and marriage status determine the reduction.

MONTANA DISABLED VETERAN ASSISTANCE PROGRAM (MDV)

The Montana Disabled Veterans (MDV) Assistance Program helps disabled veterans or their unmarried surviving spouse by reducing the property tax rate on their home. The veteran must have 100% disability from an injury related to service. The MDV reduction is based on income and marriage status.
