PROPERTY TAX ASSISTANCE

THE FOLLOWING APPLICATION MUST BE MADE ON OR BEFORE MARCH 15, 2005 TO QUALIFY FOR THE 2005 TAXABLE YEAR. Current Montana Statute provides for tax relief of the elderly and others with low income. The 1995 Legislature amended the qualifying criteria for low income property tax reduction as follows: A recipient or recipients of employment income, retirement or disability benefits whose total income from all sources including gross business income less expenses and otherwise tax exempt incomes of all types, but not including Social Security income paid directly to a nursing home, and which totals no more than \$17,323, for a single person or \$23,097 for a married couple are entitled to property tax relief. Proof of income is required, preferably in the form of federal or state income tax filings. This will simplify approval of vour application.

The first \$100,000 or less of Market Value of any improvement on real property, a mobile home affixed to the land, or mobile home, plus appurtenant land not exceeding (5) acres, qualifies when such dwelling and land are owned or under Contract for Deed and actually occupied for at least 7 months per year as the primary residential dwelling.
