RESOLUTION CREATING DISTRICT

The following Resolution, introduced by Commissioner
Healow, who moved its adoption, was seconded by Commissioner
Deckert, and was unanimously passed and adopted.

WHEREAS, a Resolution of Intention to create Rural Special Improvement District No. 451, being a thickly populated district in Yellowstone County, Montana, designating the boundaries thereof, as designed and defined in the Resolution of Intention heretofore passed and adopted by the Board of County Commissioners of Yellowstone County, Montana, on the 22nd day of March, A.D., 1961, which said Resolution of Intention, now on file in the office of the County Clerk and Recorder of Yellowstone County, Montana, declared it to be the intention of the said Board of County Commissioners to create Rural Special Improvement District No. 451;

WHEREAS, the Board of County Commissioners of said County gave notice of the passage of the said Resolution of Intention by causing the same to be published in Two (2) issues of The Billings Times, a weekly newspaper published nearest to the place where said Rural Special Improvement District No. 451 is to be created; and also caused to be posted within the boundaries of such district, a copy of such notice in Three (3) public places, and a copy of said notice to be mailed to every person, firm or corporation owning property within the proposed district, at their last known place of address, upon the same day that such notice was first published and posted, the first publication of this notice being on the 23rd day of March, A.D., 1961. A copy of said notice and proof of its posting, publishing and mailing is

on file with the Clerk and Recorder of this County and is identical with the notice prescribed and set forth in the Resolution of Intention. This said notice described the general character of the improvements so proposed to be made and contained the estimated cost thereof, and designated Tuesday, the 11th day of April, A.D., 1961, at 10:30 o'clock A.M., as the time when, and the office of the said Board of County Commissioners in the Court House at Billings, Montana, as the place where the Board would hear and pass upon all protests that might be made against the making of such improvements or the creation of such district, and the said notice referred to the Resolution of Intention on file in the office of the County Clerk and Recorder for the description of the boundaries of such Improvement District, and the number of said Improvement District was stated in the said notice;

WHEREAS, the Board of County Commissioners of said
County having this day met in regular session, at the time and
place stated in the said Resolution of Intention and said notice
of the time for the hearing of protests against the creation of
the said proposed District and against the making of said improvements, and it appearing that the public interest requires the
creation of said Rural Special Improvement District No. 451;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Yellowstone County, Montana:

1. That the Board of County Commissioners has acquired jurisdiction to order the proposed improvement; that there is hereby created a Rural Special Improvement District described as Rural Special Improvement District No. 451, in Yellowstone County, Montana; that the general character and purpose of the improvements to be made in said District is as follows: To provide for the installation of a water main to be connected with the water system of the City of Billings, Yellowstone County, Montana, as follows, to-wit:

A Twelve Inch (12") water main on Rimrock Road from 38th Street West to 60th Street West and on 54th Street West from Rimrock Road to Bobby Jones Boulevard; An Eight Inch (8") water main on Bobby Jones Boulevard from 54th Street West to Yellowstone Country Club; and a Six Inch (6") water main on Vardon Place, Demaret Place, Lloyd Mangrum Lane, and Ben Hogan Place, in Yellowstone Club Estates, and Shirley Lane and Helen Lane, in Yerger Heights Subdivision, together with all necessary tees, valves, bends, crosses, and hydrants;

2. That payment for the work and labor and materials to be furnished in making such improvements shall be met by the execution and delivery of coupon bonds drawn against the funds of said Rural Special Improvement District No. 451;

- 3. That the name of the engineer who is to have charge of said work is SAGE ENGINEERS & LAND PLANNERS, INC., by James R. O'Brien, Engineer, of the City of Billings, County of Yellowstone, State of Montana;
- 4. That the boundaries of said Improvement District shall be, and the same are hereby declared to be the same as described and set forth in the aforesaid Resolution of Intention adopted on the 22nd day of March, A.D., 1961, which said Resolution of Intention is on file in this matter in the office of the County Clerk and Recorder of the said County of Yellowstone, State of Montana, and to which reference is hereby made for further particulars.
