

RESOLUTION

OF

BOARD OF COUNTY COMMISSIONERS OF YELLOWSTONE COUNTY, MONTANA,

CREATING RURAL SPECIAL IMPROVEMENT DISTRICT NO. 519

FOR THE LIGHTING OF STREETS IN WORDEN, MONTANA

WHEREAS, the BOARD OF COUNTY COMMISSIONERS of Yellowstone County, Montana, did, on the 17th day of September, 1968, pass a Resolution of Intention to Create a Rural Special Improvement District for the furnishment of an outdoor lighting system for the rural area and locality of Worden, Montana, specifically as depicted and displayed and legally described in the Resolution of Intention to create same, all as shown in the records of the office of the County Clerk & Recorder of Yellowstone County, Montana, and,

WHEREAS, the said BOARD OF COUNTY COMMISSIONERS did set the 8th day of October, 1968, at the hour of 10 o'clock A.M. as the time for hearing and passing on all protests, if any, against the creation of said district, and Notice of the Passage of a Resolution of Intention to Create Rural Special Improvement District No. 519 having been given by said BOARD OF COUNTY COMMISSIONERS as required by law, and,

WHEREAS, the BOARD OF COUNTY COMMISSIONERS being fully advised in the premises and having taken all matters into consideration,

BE IT HEREBY RESOLVED, that said BOARD OF COUNTY COMMISSIONERS creates Rural Special Improvement District No. 519

for the purpose of furnishment of an outdoor lighting system

for a rural area known as Worden, Montana, all as depicted, displayed and described in the file herein; that no expense of construction is to be incurred by said district for the installation of such lighting system and it is only necessary to annually secure funds for the maintenance and operation of said system, and outdoor lighting for said area can best be secured by entering a contract for such lighting with YELLOWSTONE VALLEY ELECTRIC COOPERATIVE, INC. of Huntley, Montana, for the furnishment of light and installations to the district whereby the approximate estimate of the annual cost thereof will be the sum of ONE THOUSAND SIX HUNDRED AND NO/100 (\$1,600.00) DOLLARS inclusive of incidental expenses which contract is for a period of twenty (20) years all pursuant to a contract of contemporary date herewith, and,

BE IT FURTHER RESOLVED, that the cost thereof shall each year be apportioned among the various tracts of land within said district in proportion to the lineal front footage, any part of which is in the district and abuts the street or roadway along which the lighting system is to be maintained as disclosed in the file hereon of record in the Office of the County Clerk & Recorder of Yellowstone County, Montana.
