

**RESOLUTION EXPANDING RURAL SPECIAL  
IMPROVEMENT MAINTENANCE DISTRICT #700M  
(TRASK SUBDIVISION-2<sup>ND</sup> FILING)**

WHEREAS, the Owners of C/S 3028 Tract 1 have requested to be included in RSID 700M and have requested the Board of County Commissioners to expand the boundaries of RSID 700M; and

WHEREAS, the proposed boundaries of the expanded district are described as Lots 1-5, Block 1, Trask Subdivision, second filing and C/S 3028 Tract 1, Yellowstone County, Montana,, (Exhibit A) and more particularly shown in Exhibit B (map); and

WHEREAS C/S 3028 Tract 1 is contiguous to property in RSID 700M and that the boundaries of RSID 700M may be expanded to include C/S 3028 Tract 1 and assessed in the same manner as current properties within RSID 700M; and

WHEREAS, pursuant to §7-12-2161(4), MCA, the Commissioners have the power of changing, by resolution, the boundaries of any maintenance district not more than once a year; and


WHEREAS the boundaries of RSID 700M have not been changed within the last year.


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Yellowstone County, Montana, deeming the public interest or convenience require, and having received an adequate Petition for the expansion of the Rural Special Improvement Maintenance District, does hereby expand the following described Rural Special Improvement Maintenance District:


- 1. DESCRIPTION OF IMPROVEMENTS, DESCRIPTION OF MAINTENANCE, METHOD OF ASSESSMENT AND ESTIMATED COSTS.** Assessments collected on behalf of this district shall be used for the maintenance, preservation, and repair of the streets located within the boundaries of this district. All of the costs of the district shall be assessed equally on a per lot method for existing and future lots. Estimated costs are not exclusive of other eligible street expenditures.
