## RESOLUTION EXPANDING RURAL SPECIAL IMPROVEMENT MAINTENANCE DISTRICT R.S.I.D. #726M (HILL ESTATES SUBDIVISION)

Assessments collected on behalf of this district shall be used for the maintenance, preservation, and repair of the streets located within the boundaries of this district. All of the costs of the district shall be assessed equally on a per lot method for existing and future lots.
