

**YELLOWSTONE COUNTY BOARD OF COUNTY COMMISSIONERS**

Resolution No. 25- 136

**Resolution to Expand Yellowstone County Rural Special Improvement District No. 733M**

WHEREAS, pursuant to Sections 7-12-2161(4) of the Montana Code Annotated, a board of county commissioners has the authority to expand a rural special improvement district to maintain public improvements such as roads, dry hydrants and parks. To expand a district a board of county commissioners passes a resolution of intent to expand the district, sets a public hearing on the expansion, mails notice of the public hearing to the landowners in the district, publishes notice of the public hearing, receives protests on the expansion, receives comments on the expansion, holds a public hearing, considers the protests and comments and passes a resolution to expand the district. A board of county commissioners can only expand a district if it would be in the best interest of the public, the district can pay its debts and enough landowners have not protested the expansion.

WHEREAS, on November 18, 2025, the Yellowstone County Board of County Commissioners passed a resolution of intent to expand Yellowstone County Rural Special Improvement District No. 733M and set a public hearing on the expansion for December 30, 2025. On November 21, 2025, and November 28, 2025, the Yellowstone County Clerk and Recorder published notice of the public hearing. On November 21, 2025, the Clerk and Recorder mailed notice of the public hearing to the landowners in the District. On December 30, 2025, the Board held a public hearing on the expansion. The Board determined it would be in the best interest of the public to expand the District. Parcels that receive benefit from the maintenance of roads within Rural Special Improvement District No. 733M are not currently included within the District. Not enough landowners protested the expansion of the District.


NOW THEREFORE, BE IT RESOLVED,

The Yellowstone County Board of County Commissioners expands Rural Special Improvement District No. 733M to maintain Red & King Gulch Rd in C/S 2307. The Yellowstone County Public Works Department and the Yellowstone County Finance Department shall make the necessary adjustment to the District to recognize the expansion. The assessment for the expansion of the District will begin to appear on the 2026 tax statement for the landowners in C/S 2307.

Passed and Adopted on the 30<sup>th</sup> day of December 2025.



Dear Board of County Commissioners and Finance Department:

Public Works has received outreach from property owners regarding the maintenance of Red and King Gulch Roads in C/S 2307 (The District). In response, the Department reviewed District boundaries for consistency with current benefited parcels. That review identified several parcels that receive benefit from the maintenance of roads within Rural Special Improvement District No. 733M but were not originally included in The District.

In accordance with § 7-12-2161(4), MCA, the Department respectfully requests that the Board consider initiating an expansion of The District boundary to include these clearly benefited parcels.

Attached is a report that includes:

- A list of the parcels proposed for inclusion
- A map illustrating the current and proposed boundaries

We request that the Board review this report and schedule the matter for discussion at a future work session. If the Board concurs with the proposed expansion, Public Works will assist with preparation of the resolution of intent, public notices, and other required documentation.

Please let us know if any further information is needed.


