## RESOLUTION TO CHANGE THE BOUNDARY OF RURAL SPECIAL IMPROVEMENT MAINTENANCE DISTRICT #752M (EMERALD HILLS SUB- FOREST HILLS DR)

WHEREAS, pursuant to §7-12-2161(4), MCA, the Commissioners have the power of changing, by resolution, the boundaries of any maintenance district not more than once a year; and

WHEREAS the boundaries of RSID #752M have not been changed within the last year; and

WHEREAS, it has been determined that one property adjacent to the existing Rural Special Improvement District #752M boundaries is a benefited property accessing the district roads; and

WHEREAS, the benefited property status requires the change of boundaries for RSID #752M for the maintenance of streets within the district; and

WHEREAS, the boundaries of the district will be changed to include tax codes C17227, Yellowstone County, Montana, described in Exhibit B; and

WHEREAS, lots to be included from the district and boundaries of the district are shown in Exhibit A (map).

WHEREAS, on August 9, 2022, the Yellowstone County Board of County Commissioners passed a resolution of intent to change the boundary of Rural Special Improvement District No. 752M. A public hearing on the boundary change of the District was set for September 13, 2022. On August 12, 2022, the Yellowstone County Clerk and Recorder mailed notice of the hearing to all property owners in the District. On August 12, 2022 and August 19, 2022 the Yellowstone County Clerk and Recorder published notice of the public hearings in the Yellowstone County News. On September 13, 2022, the Board held a public hearing on the boundary change of the District. The Board heard comments on the district and considered protests as to the boundary change of the District. The Board did not receive enough protests to prevent the change of the District. No property owners protested the boundary change of the District. The Board believes that it is in the best interest of the public to change the boundary of the District.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Yellowstone County, Montana, deeming the public interest or convenience require, intends to change the boundary of Rural Special Improvement Maintance District 752M Emerald Hills Subdivision- Forest Hills Drive.


