RURAL SPECIAL IMPROVEMENT DISTRICT NO. 79

County, Montana, being in regular session and having this day received a petition for the creation of a rural improvement district for the purpose of installing a six inch water main to serve Lots 2 to 16, inclusive, in Sandra Subdivision, Yellowstone County, Montana, said main to be constructed along the center line of Charlene Street and connected to the existing main on Belknap Avenue, which said petition is signed by sixty per centum or more of the freeholders affected thereby, and it appearing that the proposed special improvement district is in a thickly populated locality outside the limits of an incorporated town or city and near to the City of Billings, Yellowstone County, Montana, and that it will be to the public interest and convenience to grant said petition;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF YELLOWSTONE COUNTY. MONTANA:

- 1. That the Board of County Commissioners hereby finds and determines that the signers of the said petition are more than sixty per centum of the freeholders affected by the proposed special improvement district;
- 2. That the public interest and convenience requires, and it is deemed necessary to order and create, and the Board of County Commissioners of Yellowstone County, Montana, intends to order and create a rural special improvement district as requested by said petition and as described in the succeeding paragraphs of this resolution;

3. That the number of said improvement district of hereby designated as Rural Special Improvement District No. 79 of the County of Yellowstone. State of Montana; 4. That the boundaries of said district shall be the same as the boundaries of Lots 2 to 16, inclusive, of Sandra Subdivision, Yellowstone County, Montana, according to the official plat thereof on file in the office of the County Clerk and Recorder, of Yellowstone County, Montana; 5. That the general character of the improvements to be made are to install a six inch water main along the center line of Charlene Street to serve Lots 2 to 16, inclusive, of Sandra Subdivision, with water, and connecting said main with the existing main on Belknap Avenue; 6. That the name of the engineer who shall have charge of said improvements is hereby designated as C. E. Durland, County Surveyor of Yellowstone County, Montana; 7. That the approximate estimated cost of said improvements within such proposed district is the sum of \$3,690.00, or \$258.00 per acre; 8. That on Saturday, the 10th day of MAY, 1947, at the office of the Board of County Commissioners of Yellowstone County, Montana, at eleven o'clock A.M., of said day, the said Board of County Commissioners intends to create such rural special improvement district and will hear and pass on protests to the same at said time and place by any person, or persons, who are owners or agents of owners, of any Lot or parcel of land within said proposed improvement district, who within fifteen days after the first publication of notice of the passage of this resolution, have delivered to the County Clerk and Recorder of the County of Yellowstone, State of Montana, protests in writing against the proposed work or improvements or against the creation of the district to be assessed, or both, and the persons shall have - 2 -

the right to appear at said time in person or by counsel and show cause, if any there be, why said resolution shall not be finally adopted and why the improvements should not be made.

9. The following Notice of the adoption of said resolution shall be published in two issues of a weekly newspaper published nearest to the place where such improvement district is to be created, hereby designated as The Billings Times; and the County Clerk and Recorder of Yellowstone County, Montana, is hereby ordered to post or cause to be posted within the boundaries of such improvement district, a copy of such notice in three public places, and said County Clerk and Recorder is further ordered and directed to mail a copy of said Notice to every person, firm or corporation, or the agent of such person, firm or corporation owning property within the proposed district, at his last known place of residence upon the same day such Notice is first published or posted.

Reference is hereby made to the resolution of intention on file in the office of the County Clerk and Recorder of Yellowstone County, Montana, for a description of the boundaries of such improvement district.

The estimated cost of the proposed improvements is the sum of \$3,690.00, or \$258.00 per acre, exclusive of interest charges, which said cost is to be assessed against said rural special improvement district.

That the Board of County Commissioners of Yellowstone County, Montana, will be in session at the office of said Board of County Commissioners at the courthouse in the City of Billings, Montana, on Saturday, the 20th day of April, 1947, at 11:00 o'clock A.M. of said day when and where it intends to

create the said rural special improvement district, at which time and place the Board of County Commissioners will hear and pass upon all protests against the making of said improvements or the creation of said district that may be made by any person or persons who are owners, or agents of owners of any Lot or parcel of land in the proposed district, and who have delivered to the County Clerk of Yellowstone County, Montana, protests in writing against the proposed work or against the creation of said proposed improvement district, or both, within fifteen (15) days after the first publication of this notice, and they shall have the right to appear at said time in person or by counsel and show cause, if any there be, why the improvement district should not be created.
