To: Vehicle Owner

To ensure the prompt removal of a vehicle from your property, please follow these guidelines in preparing the vehicle for removal.

1. Remove all garbage/accessories from the vehicle. This includes refuse, clothing, blankets, or any other items that are not original components of the vehicle.
2. Make sure there are no more than five tires with the vehicle (four with one spare). More than five tires per vehicle will not be removed.
3. Make sure the vehicle is easily accessible, and that doors are unlocked. If you have keys for the vehicle, please place them in the vehicle.
4. Please make sure you are totally finished with the vehicle, to avoid release charges.
